PUBLIC NOTICE / PUBLIC HEARING

The City of Elizabeth proposes the following substantial amendments to its HOME Investment Partnership Program for fiscal Years 2013 and 2016 as follows:

In Fiscal Year 2013 (CD-39), the Housing Authority of the City of Elizabeth was allocated \$200,000 in HOME Rental Program funds to rehabilitate various units. However, they were unable to utilize the funds within the timeframe allowed. The reallocated funds will be used for the construction of 4 new affordable housing units located at 80-82 Division street and 84 Division Street by Magill Real Estate Holdings, LLC, P.O. Box 6535, 806 E. Jersey St., Elizabeth, NJ 07202.

In Fiscal Year 2016 (CD-41), Y Homes CHDO was allocated \$97,015 in HOME CDHO Rental Program funds for the creation of 2 affordable housing units. Since then, Y Homes CHDO has withdrawn their application, requiring the reallocation of these CHDO funds. The reallocated funds will be used for the construction of 2 new affordable housing units by the CAPC / Elizabeth Coalition to House the Homeless, CHDO, 108 Division Street, Elizabeth, NJ 07201.

The City of Elizabeth proposes the following substantial amendments to its Community Development Block Grant for fiscal Years 2016 as follows:

In Fiscal Year 2016 (CD-42), the Elizabeth Library was originally allocated \$68,060 for ADA improvements in the bathroom of the main branch and the City of Elizabeth was originally allocated \$107,715 for the demolition of blighted and/or hazardous structures. The allocation for the ADA improvements at the Elizabeth Library needs to be increased by \$20,000 to \$88,060 because of various change orders in the construction. Additionally, the allocation for the demolition of blighted and / or blighted structures will be lowered by \$20,000 to \$68,060 because the demolition costs were less expensive than anticipated.

Public Hearing

A Public Hearing has been scheduled for Monday, July 31st, 2017 at 5:30PM in City of Elizabeth Council Chambers, 50 Winfield Scott Plaza – 3rd Floor, Elizabeth, NJ 07201 to allow the general public to comment on the proposed substantial amendments. Comments may also be submitted in writing to Eduardo J. Rodriguez, Director – Planning & Community Development at the above address in Room 114. All comments received will be considered prior to amendment implementation. The Public Comment shall begin upon publication on July 19th, 2017 and end on August 19th, 2017. Comments received after that date will not be considered.
